- a) Pursue and assist in formulation of an 'Export Strategy' by the State Government which should, inter-alia, include an action plan to
 - o Address infrastructure constraints in order to facilitate faster movements of goods.
 - o Streamline taxation such as VAT/Octroi/State level cess – refund issues.
 - o Streamline clearance – land environment and regulatory issues.
 - o Improve quality and standards to meet international norms including setting up of testing facilities.
 - b) Participate in the State Level Export Promotion Committee (SLEPC) meetings chaired by the Chief Secretary of the State for the ongoing projects of ASIDE.
 - c) Facilitate the various capacity building initiatives in the State like the 'Niryat Bandhu' scheme of DGFT, dissemination of export awards etc.
 - d) Participate in meetings with the nodal agencies/export Commissioner to discuss progress of export infrastructure projects in the State.
 - e) Infrastructure and facilitation for Towns of Excellence and meetings with the Exporters' Organizations will also be part of the mandate of Nodal officers.
